was the consensus of the meeting to invite Dan Stewart to attend the next ETMD meeting to gain his perspective on the proposed US Bike Rte 1.

- 7. After a dialog, it was agreed that each trustee will submit an article to editor John Andrews for the winter 2010 Annual ETMD Newsletter by 15 Nov. To be mailed with a letter requesting that towns budget their annual dues payment during the first two weeks of January 2010.
- 8. Because Unitil has been bringing safety problems caused by non-ET-related individuals to the attention of ETMD, a plan was proposed to organize a meeting of all ET corridor town public works departments and invite Unitil to attend and to provide safety guidelines. Some incidents were reported: Apparently an IF&W biologist drove stakes into the pipeline corridor as part of a study to collect data on bats. It was reported that Brown Industrial Group dropped large trees on top of the pipeline as part of the KAB project that is being monitored by GSGT and MDOT.
- 9. Jessica Wagner reported that OOB and Scarborough PD's were awarded a grant to police ATV trespass on the ET and that because the money has been spent, monitoring has ended. Bob LaNigra and John Andrews reported that recent ATV trespassing has resulted in surface damage. No motions.
- 10. Because the 2<sup>nd</sup> Wednesday in November is Veterans Day, and Kennebunk Town Hall will be closed, the meeting consensus was to investigate holding the meeting at North Dam Mill in Biddeford on November 4, a week early, avoding the holiday and allowing Trustees the opportunity to visit the ET office. Carole Brush will investigate.
- 11. At 10:35, Dan Letelier moved adjournment. Harry Tomah seconded. Unanimous. Next meeting target plan: 4 November at 8:30 am in North Dam Mill, Biddeford.

- 1. Chairman Hamblen called the meeting to order at 8:37 A.M.
- 2. Harry Tomah moved acceptance of the August Minutes (There was no September meeting.) Jessica Wagner seconded. Unanimously approved.
